- I. The Pre -Congress Board proposed that 25,000 Euros (of the total IAW assets by end of 2016) be moved to a Fund for the purpose of delivering a wide range of support for IAW activities to be approved by the Executive Committee.

  This could, for example, be money for organizing regional meetings and participation (ADOPTED). Jessika Kehl-Lauff commented on the potential costs of the Fund: this might not be the right moment to initiate this Fund since IAW currently runs an annual deficit, not counting paying for a database, and nobody has calculated what additional costs this fund might incur, let alone the needed regulation.
