Discord deepens over Iraq resolution

A general debate on Iraq opened on Wednesday the 16th at the United Nations in New York. Iraq has agreed to the inspectors' return. Russia says the United States must make changes to a draft United Nations resolution threatening force against Iraq. Moscow's view has been backed by the French. If a Security Council resolution is to pass, it must avoid a veto from any of the permanent members the US, Russia, France, Britain and China.

Meanwhile the huge bomblast in Bali last weekend has left many dead and badly injured and our sympathy goes to all the victims and their families. How is the world and, in particular, the UN and the US reacting to this and how will it affect the debate on Iraq?

NGOs call on the United Nations for a WCW 2005

At the UN NGOs call for the Fifth World Conference on Women, a WCW 2005 to meet the needs of women arising from new global trends, related in particular to economic globalisation, trade, new technologies, armed conflicts and the threats posed by HIV/AIDS.

The NGOs call for the governments to reconfirm their commitment to the Beijing PfA and to develop further strategies to meet the new and emerging issues that are of great concern for women.

Gender Related Violence is Global

Up to 70% of female murder victims worldwide are killed by their male companions and as many as one-third of girls are forced into their first sexual experience, according to a World Health Organisation report, which urged countries to no longer treat violence solely as a "law and order issues". Now, armed with data on the extent of the problem and nine recommendations to address it, the World Health Organisation will conduct an 18-month violence-prevention campaign. WHO Report, 6.10.02. Violence Against Women, November 25 – December 10, 2002

16-days of Activism is a period that is used to create a solidarity movement that raises awareness around gender-based violence as a human rights abuse.

This year's campaign activities explore the **intersection** of culture or religion and violence against women and children. In all regions of the world, culture or religion has been used by individuals and institutions to support beliefs, norms, practices and institutions that legitimise and perpetuate violence against women and children. Although culture is still not an easy word to define; we can begin by

understanding that culture relates to shared patterns such as values, attitudes, beliefs, rituals, goals and behaviours. These patterns can be seen in **all** societies; members of communities can share similar cultural practices, times of war can invoke certain attitudes and practices etc. However, it is important to remember that culture is not static; it is always changing.
