Also "New Issues" (paras 20-27), members to decide by "explicit consensus" modalities (including whether/when) for launching negotiations on investment, competition policy, transparency in government procurement and trade facilitation, "Environment", paras 32-33 and "Agriculture" paras 14.

Participants and civil society organisations are already convening in Cancun, Mexico, for a number of workshops, teach-ins, meetings and informal talks between Members. Meanwhile, WTO General Council Chair Carlos Perez del Castillo, with Director-General Supachai Panitchpakdi, issued a cover note to accompany the draft ministerial text at Cancun, highlighting areas where major divides persist between

Members. While the process generally has moved from Geneva to Cancun, members managed to agree on a pre-Caucun solution to **poor countries' access to essential medicines** in Geneva over the weekend. DEBTS IN DEVELOPING COUNTRIES

Export Credit Agencies or ECAs

Citizens worldwide are increasingly aware of global institutions (like the WTO and the World Bank) and their impacts on the environment and human rights. But other secretive government bodies, export credit agencies, have as big, if not bigger, impacts on the process of globalization.

Export Credit Agencies, commonly known as ECAs, are public agencies that provide government-backed loans, guarantees and insurance to corporations from their home country, that seek to do business overseas in developing countries and emerging markets. Most industrialized nations have at least one ECA. A list of major ECAs is to be found on http://www.eca-watch.org/eca/directory.html

Environmental and Social Policies

ECAs are now the world's biggest class of public IFIs (international finance institutions), collectively, exceeding in size the World Bank Group. Yet, like the World Bank Group 20 years ago, **most ECAs have no social and environmental standards**. As a result, ECA-backed projects often despoil the environment and disrupt the lives of the communities.

The International NGO ECA Reform Campaign objectives are to see that all ECAs adopt and upgrade environmental and social policies and to support the advocacy efforts of affected people against specific harmful projects.

Debt Aspects related to ECAs

Developing countries incur debt from export credit agencies by either borrowing directly from export credit agencies, or by guaranteeing a project that may not be productive. Export credit agencies universally require the government to guarantee their investment or to counter-guarantee their own guarantee extended to the project. **Export credit agencies operate in secret**. Therefore, people do not know that the government is incurring new debt, or guaranteeing a particular private sector project.

Impacts of borrowing

Like the World Bank, export credit agencies often support projects with questionable or negative development impacts. Mines, large-scale dams, pulp and paper, all kinds of development debacles are financed by export credit agencies.
