Oppose U.S. Interference in the World Health Organization!

Dear Friends,

Since March, the U.S. government has been pressuring the World Health Organization (WHO) not to include two FDA-approved drugs -- mifepristone (aka RU 486) and misoprostol – on its List of Essential Medicines. These drugs are proven to safely terminate early-stage pregnancies and could **save the lives of many of the 68,000 women who die each year from unsafe and botched abortions around the world.** However, listing of the drugs is now embroiled in what a WHO spokesman has said is a "political matter".

Click here to send emails now to Dr. Lee Jong-Wook, the Director-General of the WHO, to ask that these approved drugs be added to the List of Essential Medicines immediately.

Join our colleagues at International Planned Parenthood Federation/Western Hemisphere Region who have initiated a global action to protest this **latest outrage in the Bush administration's strategy to bully the rest of the world** with its backward, dangerous stance on reproductive health and women's rights. Every day of delay results in women dying unnecessarily from complications of unsafe abortion.

ACT NOW to support the lives of women and girls and the integrity of public health research by urging the WHO Director-General to resist outside pressure and add the approved drugs to the List of Essential Medicines without further delay.
