Measures to the Strategic Goals

Adopted at the XL Congress November 2025

Prologue

The International Alliance of Women — Equal Rights — Equal Responsibilities works to advance women's human rights, gender equality, and social justice worldwide.

The Action Programme 2025–2028 Measures to the Strategic Goals complements the Strategic Goals document by outlining how these goals will be achieved through coordinated action, advocacy, and partnerships at all levels.

- **1. Human Rights** *All women and girls fully enjoy their human rights as recognized by international conventions*, *with no one left behind*.
 - a. Advocate for ratification, lifting of reservations, and full implementation of all UN Human Rights Conventions, especially CEDAW.
 - b. Submit and support alternative reports to CEDAW, UPR, and other treaty bodies; monitor state compliance.
 - c. Support "Cities for CEDAW" initiatives where national ratification is missing.
 - d. Work for protection of rights of refugee, migrant, minority, and indigenous women, including cultural rights.
 - e. Strengthen women's participation in human rights processes and empower them as agents of change.
 - f. Promote inclusion of gender equality and human rights education in all public and political systems.
- **2. Peace** The human right to peace is universally recognized and protected by binding international law, with women equally represented in all peace and security processes.
 - a. Advocate for a UN Convention on the Human Right to Peace with a treaty body and optional protocol.
 - b. Promote and monitor implementation of UNSCR 1325 and the Women, Peace & Security (WPS) Agenda.
 - c. Support women's participation in peace negotiations and peacebuilding at all levels.
 - d. Work for disarmament and control of arms trade, including small arms and nuclear weapons.
 - e. Advocate for recognition of femicide as a crime under international law (Rome Statute amendment).
 - f. Promote peace education and interreligious/intercultural dialogue.

- g. Collaborate with women's peace NGOs globally and ensure their voices reach UN processes.
- **3. Ending Violence Against Women and Girls** *All forms of violence against women and girls are eliminated through the universal enforcement of human rights, equality, and justice.*
 - a. Advocate for universal ratification and enforcement of the Istanbul Convention and the new AU Convention on Ending VAWG.
 - b. Lobby for national laws and mechanisms for prevention, protection, prosecution, and survivor support.
 - c. Strengthen shelters, legal aid, and trauma services for victims of violence.
 - d. Combat emerging forms of cyberviolence, trafficking, and femicide.
 - e. Engage men and boys in education to end toxic masculinity and gender-based violence.
 - f. Cooperate with UN Special Rapporteurs and submit shadow reports on VAWG.
 - g. Support survivors' access to justice and compensation, nationally and internationally.
- **4. Democracy** *Democracies worldwide ensure gender parity, inclusive participation, and equal representation of women in all decision-making processes.*
 - a. Promote legal reforms for parity democracy and electoral quotas.
 - b. Advocate for women's participation and leadership in all political, judicial, and economic sectors.
 - c. Build alliances to resist the global backlash against women's rights and democracy.
 - d. Monitor and expose threats to democratic participation and civic space.
 - e. Increase women's digital literacy to enhance democratic engagement.
 - f. Model democratic governance within IAW itself and promote it externally.
 - g. Support protection of women human rights defenders and civil society actors.
- **5. Climate Change** Climate action is fully gender-responsive, ensuring women's leadership, participation, and protection from climate-related risks.
 - a. Advocate for gender-responsive climate policies and full implementation of the Paris Agreement.
 - b. Integrate women's rights into all climate policy, adaptation, and mitigation frameworks.
 - c. Prioritize the needs of women climate refugees, rural women, and women food producers.
 - d. Promote women's participation in environmental decision-making and climate finance mechanisms.
 - e. Conduct education and advocacy on women's health and SRHR in the context of climate change.
 - f. Support IAW members' engagement in UNFCCC processes and ensure observer participation.
 - g. Encourage clean energy solutions (e.g., universal access to clean cooking technologies).

- **6. Health** All women and girls have universal access to gender-sensitive healthcare and full realization of their sexual and reproductive rights.
 - a. Advocate for universal access to SRHR services, including contraception, safe abortion, and maternity care.
 - b. Promote comprehensive sexual education for adolescents.
 - c. End all harmful traditional practices such as FGM/C and child marriage.
 - d. Support research and services in gender medicine, including menopause and endometriosis care.
 - e. Lobby for free or affordable menstrual hygiene products and eliminate the "pink tax."
 - f. Advocate for gender-sensitive healthcare training and inclusion of women's health in medical curricula.
 - g. Promote data collection and reporting on maternal mortality and women's health indicators.
- **7. Women in the Economy** Economic systems ensure equal participation, pay equity, and recognition of unpaid care work as essential to sustainable economies.
 - a. Advocate for ratification and implementation of ILO conventions and CEDAW on women's economic rights.
 - b. Promote gender-responsive budgeting and equal pay for equal work.
 - c. Recognize and redistribute unpaid care work; promote a caring economy.
 - d. Ensure women's access to social protection, pensions, and formal employment.
 - e. Support women's entrepreneurship, access to credit, and business networks.
 - f. Strengthen women's representation in economic decision-making and trade unions.
 - g. Promote gender impact assessments of all economic policies and crisis responses.
- **8.** Digital Equality and Cyber Safety Women and girls have equal and safe access to digital spaces, free from online harassment and gender-based cyber violence.
 - a. Advocate for laws criminalizing cyber violence and enforcing accountability of perpetrators and tech platforms.
 - b. Promote digital literacy and equal access for women and girls, including in STEM fields.
 - c. Push for inclusive and affordable internet infrastructure worldwide.
 - d. Ensure AI systems and algorithms are free of gender bias and harmful stereotypes.
 - e. Promote responsible data governance and global regulation of AI for human rights compliance.
 - f. Integrate awareness of cyber safety and online violence prevention into education at all levels.
 - g. Support victim assistance, reporting mechanisms, and cross-border cooperation on cybercrime.
